### **What can I expect to do in this role?**

#### **Work Description:**

Student Security Guards (Ontario Place Corporation) work as part of the larger security team to ensure compliance with safety regulations and procedures of the park, guests, and staff.

As an Ontario Place Security Guard, you may have the opportunity to work on some or all of the following activities:

- Interact with guests to provide directions to various areas of the park, surrounding venues, and transportation.
- Clarify information to site patrons and guests.
- Manage traffic, and perform traffic escorts.
- Conduct crowd control practices.
- Attend to minor first aid calls.
- Maintain the safety of the public and assist in diffusing escalated situations in a professional manner.
- Recognize escalating complex situations and notify Supervisors.

### **How do I qualify?**

#### **Mandatory**

1. **Student Status:** All summer jobs require a “student” status. A student is defined as someone enrolled in a secondary or post-secondary institution (currently or for the fall semester) or has graduated within the past six months. If you graduated in January, you could apply for and start a summer student position in the Ontario Public Service up until June of that year.
2. You must be a minimum of 18 years of age. There is no maximum age limit for applying to summer student positions. Age parameters will be provided on the job advertisement and you must meet all age requirements by May 1<sup>st</sup>.
3. **Residency:** You must be a resident of Ontario during the term of employment.
4. **Work Status – Ability to Work in Canada:** You must be legally entitled to work in Canada. You are also required to have a valid Social Insurance Number (SIN) upon being hired.

## **Skills**

### **Communication and Interpersonal skills:**

- You apply your written communication skills to prepare a variety of documents (e.g. incident reports).
- You apply your customer service and interpersonal skills to interact with and assist guests by providing information.

### **Technical Skills and Knowledge:**

- You apply your general knowledge of law enforcement regulations and procedures, and are able to understand and apply generally accepted safety and security techniques.

### **Other Requirements:**

- You must have a valid Ontario G1 (or higher) Driver's License or equivalent.
- You must have valid and current basic CPR and Standard First Aid certificate.
- Must have Smart Serve or the ability to acquire before starting contract.
- You are willing and able to work a rotating shift schedule, including weekends and statutory holidays.

### **Conditions / Environment:**

Work is performed in an outdoor environment.
